Our sales are subject to the general conditions expressed herein, which prevail over any other conditions that may appear in any other document of the purchaser, unless expressly and formally indicated by us.

- 1. In the enclosed price list or economic offer, you will find the prices in force, exempt from the corresponding VAT.
- The contract of sale or supply is made at the registered office of BRAFIM MECPLAST, S.L. Buyer and Seller accept the application of Spanish Law and the jurisdiction of the Courts and Tribunals of the city of Barcelona, expressly waiving their own jurisdiction and domicile.
- 3. The technical information, instructions for use, etc., given verbally or in writing by BRAFIM MECPLAST, S.L. or its Agents in no case imply our responsibility for the results obtained, given that we cannot control the way in which our products are used. Our guarantee is limited to the quality of the product and its continuity. We decline all responsibility for any accidents that may arise from the use of our products.
- 4. The customer shall examine the goods to check that the quantity and quality conforms to what was ordered. In this case, complaints will only be dealt with if they have been made within 8 days of receipt of the goods. Furthermore, if the goods are to be returned to the Seller for reasons attributable to the Buyer, the handling and preparation costs shall be borne by the Buyer.
- 5. The Company assumes no responsibility for delivery delays caused by accidents or force majeure.
- 6. RESERVATION OF TITLE. The goods remain the property of BRAFIM MECPLAST, S.L. for as long as their total sale value has not been paid for by the Buyer. While this situation lasts, the Seller reserves the right of ownership of the goods and may remove them from the Buyer's address.
- 7. The dies, tools and tooling shall be charged to the customer and shall be the property of Brafim. Any tooling, tooling, dies, molds, etc. necessary for the manufacture of custom parts for the customer, which have not been used in the last two years will be destroyed or disposed of in the absence of notice from the customer indicating any other course of action.
- 8. Any product supplied by the customer for the preparation of the offer will be destroyed or disposed of, if there is no order to the contrary by the customer, three months after the preparation of the offer.
- All operations carried out are insured by a surety and credit company, and it is therefore this company that sets the level of risk that can be assumed by BRAFIM MECPLAST, S.L. The client has the right to know the value of this risk limit.
- 10. Partial deliveries will not be accepted unless invoices and partial payments are accepted by the Client.
- 11. In special or custom manufacturing, due to the manufacturing process, there may be a variation of + / 5 % of the quantities ordered.
- 12. The cancellations of orders and / or returns of material according to catalog will be subject to the appropriate charges for cancellation / return / restoration / storage, this amount will never be less than 15% of the total canceled or returned by the Customer, invoiced without the need for new order by the Customer.
- 13. In those orders in which special manufacturing is involved, cancellations and/or returns will not be admitted under any circumstances, so please verify to the maximum the characteristics of the same.
- 14. The shipments to postage due always travel at the expense and risk of the buyer.
- 15. Any incident that occurs in transport must be communicated at the time of receipt to the carrier, by means of the transport voucher, provided that the damage is visible. Otherwise, they have 24 hours to verify the condition of the goods and notify any anomalies. After this period, no claims will be accepted for this concept.
- 16. The description is merely a mnemonic reference, since the BRAFIM drawing and the part code or reference will prevail as a definition of the part.
- 17. Orders placed by any of the available means will be subject to our supply availabilities. We decline any responsibility in case of delays due to impossibility of supply. BRAFIM MECPLAST, S.L. will only accept orders from companies, not from individuals, and reserves the right not to accept such orders.
- 18. We reserve the right to make any modifications to our products that we consider necessary. The characteristics of the products may be modified if necessary. In case of change of reference model, the changes will be indicated in advance.
- 19. In the event of cost fluctuations in the market, BRAFIM MECPLAST, S.L. reserves the right to modify prices without prior notice. However, before serving an order with items priced differently from this price list, the customer will be informed. This price list or offer cancels the previous one.
- 20. For cardboard items and according to the tolerances adopted by AFCO, the delivery quantities may vary by 25% up to 500 und. 20% for deliveries from 500 to 1000 und. and 10% for orders from 1001 to 15000 und.
